Terms and conditions of The Vintage Corporation

Please note that the date is pencilled in our diary when you confirm the booking.

The date will be firmly booked in our diary when deposit of 20% is received.

1. Cancellation of this contract shall be as follows :

Date of cancellation	Cancellation Charge
3 months before the event date	20% of deposit
1 to 2 months before the event date	50% of total booking fee
2 weeks to 1 month before the event date	70% of total booking fee
Less than 2 weeks before the event date	100% of total booking fee

2. This contract constitutes a complete and binding agreement between the client/employer and The Vintage Corporation.
3. The client agrees that the booking will not be secured until The Vintage Corporation has received their booking form, signed Terms and Conditions and a deposit.
4. The Vintage Corporation agrees that the booking fee is fully inclusive of all expenses, travelling expenses to and from the venue unless otherwise stipulated in the contract.
5. The Vintage Corporation warrants that all equipment is in good working order, and fit for its purpose, and that no part of the performance is likely to be a danger to the artiste/s or any other person/s.
6. The adjustment of the volume and sound level of any equipment shall be as the client reasonably requires. However, the client understands that the volume of the band cannot be controlled in the same way as pre-recorded music. If the band is asked to play at a volume that they consider unsuitable for the venue, they reserve the right to stop playing and the client will be liable for the full booking fee.
7. No fee shall be payable to the client/employer for any day upon which this engagement shall be suspended by reason of Royal Demise, National Mourning, Fire, Epidemic, War, Strikes, lockout or by reason of order of any Licensing or Public Authority or by any other reason beyond our control.
8. The Vintage Corporation accepts no responsibility for non-fulfilment of contract, but every safeguard is assured.
9. The client/employer agrees to be responsible for harm, loss or damage of any kind to musician(s) person or property while located at the place of performance.
10. The person(s) signing for client/employer agrees to be personally, jointly and severally liable for the terms of this contract.
11. The musicians of The Vintage Corporation shall be suitably and tidily dressed during their performance.
12. The client/venue shall be responsible for the provision of a safe and adequate source of mains electricity in the performing area.
13. It is entirely the client's responsibility to make sure that the performance area is suitable for the band. It must be a safe, dry and even performance area. The temperature of the performance area must not be below 13 degrees Celsius or over 30 degrees Celsius. If the temperature falls outside of this range during set up or performance the band may refuse to perform and booking fee will not be refunded.
14. The venue must ensure that there is a safe, secure, lockable, dry and comfortable area for the musicians to change in and store their personal belongings. Toilets are not acceptable as a changing area.
15. The use of any of our equipment or instruments by any of the guests is not allowed unless permission is given by the manager of The Vintage Corporation.
16. The performance area must be accessible for large vans and a large trailer.
17. The client must make sure that there is sufficient legal parking facility close to the performance area for at least 10 cars. The client must also make sure that the unloading and loading are no further than 100 yards from the performance area.
18. The Vintage Corporation requires approximately 4 hours to unload, setup and test the equipment. We will arrive approx. 4 hours before the first time of the performance regardless of whether guests are present at the venue. The Vintage Corporation will need approx. 1 hour after the performance to dismantle all the equipment and load. Please make sure that the venue managers are aware of this agreement.
19. If the client/employer requires The Vintage Corporation to play after the agreed times, this can be arranged at some venues at £500.00 for each additional hour.
20. If The Vintage Corporation are unable to setup or start performing at the agreed times as indicated on the booking form for reasons beyond their control, we will not be obliged to extend the performance or finish performing at a later time than agreed.
